#### **RECLAMATION DISTRICT NO. 2084**

#### **RESOLUTION NO. 2021/22 - 12**

#### PROCLAIMING A LOCAL EMERGENCY PERSISTS, RE-RATIFYING THE COVID-19 STATE OF EMERGENCY, AND RE-AUTHORIZING REMOTE TELECONFERENCE MEETINGS OF RECLAMATION DISTRICT 2084 PURSUANT TO THE RALPH M. BROWN ACT.

WHEREAS, RECLAMATION DISTRICT 2084 (RD 2084) is committed to preserving and nurturing public access and participation in meetings of the Board of Trustees; and

WHEREAS, all meetings of the RD 2084 are open and public, as required by the Ralph M. Brown Act (Gov. Code, §§ 54950 - 54963) ("Brown Act"), so that any member of the public may attend, participate, and watch the District's legislative body conduct its business; and

WHEREAS, Assembly Bill 361 added Government Code section 54953(e) to make provisions for remote teleconferencing participation in meetings by members of a legislative body, without compliance with the requirements of Government Code section 54953(b)(3), subject to the existence of certain conditions; and

WHEREAS, a required condition is that a state of emergency is declared by the Governor pursuant to Government Code section 8625, proclaiming the existence of conditions of disaster or of extreme peril to the safety of persons and property within the state caused by conditions as described in Government Code section 8558; and

WHEREAS, a proclamation is made when there is an actual incident, threat of disaster, or extreme peril to the safety of persons and property within the jurisdictions that are within the District's boundaries, caused by natural, technological, or human-caused disasters; and

WHEREAS, it is further required that state or local officials have imposed or recommended measures to promote social distancing, or, the legislative body meeting in person would present imminent risks to the health and safety of attendees; and

WHEREAS, the Board of Trustees previously adopted a Resolution, number 2021/22-1 on October 7, 2021, finding that the requisite conditions exist for the District to conduct remote teleconference meetings without compliance with paragraph (3) of subdivision (b) of section 54953; and

WHEREAS, as a condition of extending the use of the provisions found in Section 54953(e), the Board of Trustees must reconsider the circumstances of the state of emergency that exists in the District, and the Board of Trustees has done so; and

WHEREAS, such conditions persist in the District, specifically, the March 4, 2020 State of Emergency Proclamation remains active in California due to the threat of COVID-19; and

WHEREAS, the Board of Trustees does hereby find that the ongoing risk posed by the highly transmissible COVID-19 virus has caused, and will continue to cause, conditions of peril to the safety of persons within the District that are likely to be beyond the control of services, personnel, equipment, and facilities of the District; and

WHEREAS, as a consequence of the local emergency persisting, the Board of Trustees does hereby find that the District shall continue to conduct its meetings without compliance with paragraph (3) of subdivision (b) of Government Code section 54953, as authorized by subdivision (e) of section 54953, and that the Board shall comply with the requirements to provide the public with access to the meetings as prescribed in paragraph (2) of subdivision (e) of section 54953; and

WHEREAS, all meeting agendas, meeting dates, times, and manner in which the public may participate in the public meetings of the District and offer public comment by telephone or internetbased service options including video conference will continue to be posted on the District website and physically outside of the District office.

NOW, THEREFORE, THE BOARD OF TRUSTEES OF RECLAMATION DISTRICT 2084 DOES HEREBY RESOLVE AS FOLLOWS:

Section 1. <u>Recitals</u>. The Recitals set forth above are true and correct and are incorporated into this Resolution by this reference.

Section 2. <u>Affirmation that Local Emergency Exists</u>. The Board has reconsidered the conditions of the state of emergency and proclaims that a local emergency persists throughout the District because the high risk of transmissibility of COVID-19 continues to pose an imminent risk to the safety of persons in the District.

Section 3. <u>Re-ratification of Governor's Proclamation of a State of Emergency</u>. The Board hereby ratifies the Governor of the State of California's Proclamation of State of Emergency, effective as of its issuance date of March 4, 2020.

Section 4. <u>Remote Teleconference Meetings</u>. District staff are hereby authorized and directed to take all actions necessary to carry out the intent and purpose of this Resolution including, conducting open and public meetings in accordance with Government Code section 54953(e) and other applicable provisions of the Brown Act.

Section 5. <u>Effective Date of Resolution</u>. This Resolution shall take effect immediately upon its adoption and shall be effective until the earlier of (i) July 2nd, 2022, or such time the Board of Trustees adopts a subsequent resolution in accordance with Government Code section 54953(e)(3) to extend the time during which the District may continue to teleconference without compliance with paragraph (3) of subdivision (b) of section 54953.

Dear Mr. Young:

Larsen Wurzel and Associates, Inc. (LWA) is pleased to submit this proposal to provide continued staff support to Reclamation District 2084 (RD 2084). The original contract between RD 2084 and LWA was executed on October 25<sup>th</sup>, 2019. Amendment No. 3 was executed on June 16<sup>th</sup>, 2021 to increase the contract value and extend support services through the 2021/2022 Fiscal Year.

LWA proposes to provide continued administration and financial administration services to RD 2084 through Fiscal Year 2022/2023. This proposal recommends extending the <u>existing contract expiration</u> to June 30, 2023 and an increase to the <u>existing contract value</u> from \$497,712 to \$553,656. Services will be charged on an actual time and materials basis up to the identified not-to-exceed amount. LWA will send requests for payment to RD 2084 on a monthly basis based upon the services delivered.

# MEMORANDUM

#### **SUBJECT:** June Engineer's Report

Trustees:

Described below are the items constituting the engineer's report to be discussed at your scheduled June 2, 2022 meeting.

**2022-23 Subventions Program – CEQA Filing –** Your Subventions CEQA filing for routine maintenance was submitted to Solano County. We will provide digital copy for your records of the filings once it's been posted.

**CDFW RMA Coordination** – We had a good discussion with CDFW, Brianne O'Rourke, regarding the language modification the District is seeking to adjust the RMA to fit the responsibilities of the District under their routine maintenance. The request includes language changes for section 2.4, to allow additional coverage between June 1 to November 30, and exceptions for work outside this work window if certified biologists, along with coordination with CDFW prior to work, determines the repair authorized under the RMA. We are working with CDFW on the language changes for broader coverage.

#### **Spring 2022 Monitoring Activities**

- 1) Animal Control, monitor rodent activity
- 2) Roadway Maintenance, as necessary
- 3) Vegetation Control, spraying as necessary
- 4) Erosion Repair, review low tide boat survey and site assessment.

**Erosion Repair Estimate/Alternatives -** 4 - 5 sites were identified during a spring low-tide boat survey performed by Westervelt. MBK evaluated these sites to generate quantity and cost estimates for District consideration on next steps. These are all small site repairs where the lower waterside levee slope has settled and created vertical erosion at sites that have been rocked and repaired over time. There is existing rock revetment below and above these erosion sites. The attached memo describes the sites, including photos, site map and estimate for repairs. There are a couple of alternatives for the District to consider for possible actions.

#### Summer - Fall 2022 Maintenance Activities

- 1) Landside slope grading; where heavy runoff rilling has occurred, as necessary
- 2) Erosion Repairs;
- 3) Freeboard Project;

**Five Year Plan** – The revised draft Five-Year Plan was provided last month for review prior to submittal to DWR. The Five-Year Plan draft will be submitted to DWR6 Friday, June 3.

**Delta Barriers** –No change, DWR is still pursuing permits (currently on DPP for 408) to investigate proposed site locations in the North Delta; False River Barrier notch is sealed back up this month and will likely stay in place through November 2022.

**RD 2084 Access – RD 536 Emergency Slip Location** – No significant change; RD 536 is evaluating design alternatives and preparing for potential bid of work later this summer. Continue to coordinate with RD 536 for any questions or updates on the status of this work. RD 536 will provide details on potential timing of work that may affect access to RD 2084 or landowners.

**DSC Delta Adapts** – The DSC is continuing to work on their outreach strategy and meeting with historic landowners to better understand the connection to the land. There will be more detail on Ag. group formation later this month. The next flood group meeting is June 2, no new information aside from an informal meeting to discuss levee standards is available; our recommendation to the DSC has been to look at the standards identified in the Delta Plan as a starting point for this flood group. Based on that initial meeting the DSC consultants are a way off from the general knowledge in the Delta on levee design and State/Federal design standards.

**DSC Social Science Initiative** – The next major milestone in the Social Science Initiative is to compile and administer a survey for Delta stakeholders. It is anticipated one more meeting will be held before the survey is presented to the public. Those surveys will be mailed out to Delta Residents and landowners later this summer.

SUBJECT: RD 2084 (Little Egbert Tract) – Erosion Inspection

The purpose of this memo is to describe the observations made during a field visit to Reclamation District No. 2084 (District) on May 17, 2022, to delineate four erosion sites and one large tree (driftwood debris) along Cache Slough. The inspection was performed by Michael Nishimura and Emily Pappalardo of MBK Engineers.

#### Sinkholes (Station 219+85):

This site includes two sink holes on the waterside slope; one located on the upper slope, and the other located mid slope. Runoff from the levee crown and rodent activity are likely the factors that caused this damage. The sink hole on the upper slope is 3.5 feet in diameter and approximately 4 feet down from the waterside hinge and is approximately 4 feet deep. The mid slope sink hole is approximately 3 feet in diameter and is 2.5 feet down slope from the first sinkhole and is approximately 2 feet deep. The entire effected slope length is about 17 feet.

#### Erosion Site No. 1 (Station 219+60 to 219+75):

Erosion on the waterside toe of levee. Existing rock was observed on a shallow bench in the tidal zone below the erosion. The length of the site is 15 feet, and the vertical scarp is 4 feet. The top of the erosion is 7 feet down from the waterside hinge.

#### Driftwood Debris Removal (Station 123+80 to 124+30):

A large 50-foot-long tree (3-foot diameter) located on the waterside slope. Existing rock observed under and around the downed tree. Tree should be removed to prevent damage during a high-water event.

#### Erosion Site No. 2 (Station 115+40 to 115+80):

Erosion on the waterside toe of levee. Existing rock was observed on a shallow bench in the water below the erosion. The length of the site is 40 feet, and the vertical scarp is 3.5 feet. The top of the erosion is 15 feet down from the waterside hinge.

#### Erosion Site No. 3 (Station 112+45 to 113+00):

Erosion on the waterside toe of levee. Existing rock was observed on a shallow bench in the tidal zone below the erosion. The length of the site is 55 feet, and the vertical scarp is 5 feet. The top of the erosion is 15 feet down from the waterside hinge.

#### Erosion Site No. 4 (Station 111+75 to 112+00):

Erosion on the waterside toe of levee. Existing rock is observed on a shallow bench below the erosion. The length of the site is 25 feet, and the vertical scarp is 3 feet. The top of the erosion is 15 feet down from the waterside hinge.

#### Erosion Site No. 5 (Station 87+75 to 88+75):

Erosion on the waterside toe and mid slope of the levee. Existing rock was observed on a shallow bench below the erosion at the levee toe. The length the site is 100 feet, and the vertical scarp is 2 feet. The top of the erosion mid slope is 6 feet down from the waterside hinge.
