Subject: Reclamation District 2084 – District Administration and Staff Support Services for Fiscal Year 2025/2026 – Amendment No. 9 to Agreement for Consulting Services

Dear Mr. Young:

Larsen Wurzel and Associates, Inc. (LWA) is pleased to submit this proposal to provide continued staff support to Reclamation District 2084 (RD 2084). The original contract between RD 2084 and LWA was executed on October 25th, 2019. Amendment No. 8 executed June 27, 2024, increased the contract value to \$859,929 and extended the contract through June 30, 2025.

LWA proposes to provide continued agency and financial administration services to RD 2084 through Fiscal Year (FY) 2025/2026. This proposal recommends an increase to the existing contract value from \$859,929 to \$1,032,201 and extending the existing contract expiration to June 30, 2026. Services will be charged on an actual time and materials basis up to the identified not-to-exceed amount. LWA will send requests for payment to RD 2084 monthly based upon the services delivered.

This budget increase is summarized in the following table. A detailed supplemental budget is attached to this letter as Enclosure 1 and a current rate sheet for LWA is attached as Enclosure 2.

SUBJECT: June Engineer's Report

Trustees:

Described below are the items constituting the engineer's report to be discussed at your scheduled June 2025 meeting.

2023-2024 Reimbursement: Your 2023 deductions have been reviewed and approved, there is one \$59.25 deduction. Your anticipated reimbursement should be close to \$111,250.

2024-25 Subventions: the fiscal year ends June 30, 2025. We have started coordination with local contractors for minor maintenance work prior to end of year; landside slope rilling repair and grading; sinkhole repairs at seepage berm. A sole source contract would repair the majority of landside damage areas; work will be completed prior to June 30. See list of sites attached

Delta Levees Program Prop 4 Update: We have heard from the Delta watermaster that Thomas Gibson (DWR Deputy Director) has stated the \$150 million earmarked for the Delta Levees Program will be distributed with \$80 million to the Delta Levees Subventions program and \$70 million to Special Projects. This should provide 5 years of Subventions Program funding at \$16 million per year. Special Project money would be dedicated to Phase 2 funding from last PSP first, and any new Phase 1-2 projects that are accepted. We are pushing for a flood focused solicitation.

Spring-Summer 2025 Activities:

- 1) Flood Season Repair Planning: MBK will document all landside riling locations for regrading and provide an estimated cost to perform the work; this may require small import of material to regrade and fill the landside shoulder areas where water is collecting and draining.; see attached site list
- 2) Erosion Monitoring: Survey results are attached; at a minimum MBK recommends addressing the serious sites listed and repairing the two sinkhole areas this fall prior to the flood season. These repairs could be done under a sole-source contract. If all sites were to be addressed it would have to be bid.
- 3) Animal Control: Continue to patrol for rodent/beaver activity, potential burrow locations will be staked for observations. Animal activity impacting levee embankments can cause rapid changes in conditions that could lead to a levee embankment failure
- 4) Seepage Repair Planning: MBK met with Neil to review seepage area from 275+00 800+00. This wet area has two landside canals; the canal closest to the levee provides irrigation water to fields upstream and the landside canal provides drainage to a lateral perpendicular to the site. There are no buried irrigation lines that are known. Elevation of drains/irrigation canals would have to be maintained with setback to accommodate seepage berm construction; 10-15 feet separation between canals is requested. These lands are part of a bird return program through DCP; construction likely couldn't start until September time period when water allocations stop. If work is performed the District should request the landowner/tenant to clear landside toe area and set lines for new canal alignments.


FEMA/OES Coordination: The District has submitted their P4 form and verified all state forms have been submitted. This likely mean funding will be provided this summer. See attached P4 form.
